Bidding is open to all eligible Bidders from all countries as defined in ITB Clause 4.
2. The *Aadarsha Rural Municipality* invites *[select: electronic* bids from eligible bidders for the procurement of *Supply and Delivery of Pipes* under National competitive bidding – Single Stage Single Envelope procedures.

A complete *set* of Bidding Documents may be purchased from the office *Aadarsha Rural Municipality* and the office *Aadarsha Rural Municipality, Mauwa-Nagardah, Doti* by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NPR 1000 till *2083 Bhadra 30 (2026 sept 15)* during office hours *in the AADARSH GA-1-1 ANTARIK RAJASWO (12051276760121)*.

Bidders who choose to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system (www.bolpatra.gov.np/egp) at no cost

5. Pre-bid meeting shall be held at *Aadarsha Rural Municipality, Mauwa-Nagardah, Doti* at *2083 Bhadra 21*.
6. Electronic bids must be submitted to the office *Aadarsha Rural Municipality, Mauwa-Nagardah, Doti* by through PPMO's e-GP system *www.bolpatra.gov.np/egp* on or before *12 Noon on 2083 Bhadra 31 (2026 Sept 16)*. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at *14 Noon on 2083 Bhadra 31 (2026 Sept 16)*, at the office of *Aadarsha Rural Municipality, Doti*. Bids must be valid for a period of *90 days* from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NPR 56000, which shall be valid for 30 days beyond the validity period of the bid.
